**FINAL DECISION  
ON THE SCHOOL ATTENDANCE BOUNDARY REVIEW  
FOR  
MILTON #3, GUARDIAN ANGELS AND OUR LADY OF VICTORY  
CATHOLIC ELEMENTARY SCHOOLS**

At the January 16, 2007 Regular Meeting of the Board, Trustees deliberated all the information provided by the Milton #3 School Boundary Review Committee (SBRC) and submitted by members of the school communities.

Trustees passed the following motion:

**RESOLVED, that, the New Milton #3 Catholic Elementary School** boundary shall consist of part of Attendance Zone V35 located north of Derry Road, south of Laurier Avenue, east of Thompson Road and west of James Snow Parkway; as well as Attendance Zone V39 consisting of the area south of the CPR Railway, north of Laurier Avenue, east of Thompson Road; and west of James Snow Parkway; and a portion of Attendance Zone V35 located south of Derry Road east of Trudeau Drive, west of James Snow Parkway and north of the gas pipeline, effective for the 2007/2008 school year, and

**That, the Guardian Angels Catholic Elementary School** boundary shall consist of part of Attendance Zone V35 located south of Derry Road, east of Thompson Road, north of Louis St. Laurent Avenue and west of Trudeau Drive; as well as a part of Attendance Zone V35 located east of Trudeau Drive, north of Louis St. Laurent Avenue, west of James Snow Parkway to the gas pipeline and south of the gas pipeline, effective for the 2007/2008 school year, and

**That, the Our Lady of Victory Catholic Elementary School** boundary shall consist of Attendance Zones P42, P45, P46, P50, P51, V40, V41, and V42; as well as the rural attendance zones of J38, K40, P35 and P37, effective for the 2007/2008 school, and

**That, the Board** provide transportation to those students residing in the redirected areas based on the Board's Transportation policy, and

**That, the Board** staff continue to monitor enrolment at all elementary schools in the Milton #3 Community and report to the Board on an annual basis.

**CARRIED**

The above resolution will result in the redirection of a portion of the existing Guardian Angels and Our Lady of Victory elementary school attendance areas to the new Milton #3 Catholic Elementary School. Please refer to the map on the reverse side of this News Release.
